## **THIS IS NOT A LICENCE**

As this is not a Licence students from other organisations may still be able to train within any of the British Wadokai Dojo available to them, without having to jeopardise their position on 'double-licencing' violations/restrictions, etc.

### **The Use of Temporary Visitors Membership.**

Temporary Visitors' Membership is primarily for students who are in the area for a while, but wish to insure but not to licence, as their main Dojo (where they train and grade) is located elsewhere. Restrictions: Restrictions of use include; BWK Gradings, Advancement, Instructing (whether temporary or permanent), Competitions & Tournaments, etc.

**Insurances** - Cover is for all related activities organised within the **British Wado Federation**. *Cover does not include training elsewhere and does not allow the use of live bladed weapons or kick-boxing.*

### **Insurance.**

A British Wadokai Insurance includes:

1. Registration & Membership to British Wadokai/British Wado Federation.
2. UK Person to Person and Public Liability Insurance cover for £5,000,000.

Due to the turnover of student memberships in martial-arts it is usually considered that if a martial-arts licence has expired it is normally due to the result of the individual terminating training & membership etc. A student who allows his/her licence to expire will result in the following:

1. Registration card is destroyed after 3 months expiry.
2. Kyu grade registration records destroyed after 3 months expiry.
3. Insurance cover becomes invalid at time of expiry.
4. Membership terminated at time of expiry.

*Once reapplication has been accepted all records are replaced.*
